

Consultancy Expenditure 2023/24

The following is a summary of consultancy expenditure by Greater Western Water over the 2023-24 financial year.

Details of consultancies (valued at \$10,000 or greater)

In 2023-24, there were 44 consultants engaged during the year where the total fees payable to the consultants were \$10,000 or greater. The total expenditure incurred during 2023-24 in relation to these consultancies was \$6,601,425 (2022-23: \$6,642,445) (excl. GST).

Details of consultancies (valued at less than \$10,000)

In 2023-24, there were 28 consultants engaged during the year where the total fees payable to the consultants were less than \$10,000. The total expenditure incurred during 2023-24 in relation to these consultancies was \$125,378 (2022-23: \$101,380) (excl GST).
