In 2022-23, there were 45 consultants engaged during the year where the total fees payable to the consultants were \$10,000 or greater. The total expenditure incurred during 2022-23 in relation to these consultancies was \$6,642,445 (2021-22: \$4,142,648) (excl. GST).
